Including all of each person's corporations and organizations officers, agents, servants, employee's, lessors; (herein after collectively referred to as "Releases"), from any and all liability, claims, demands or actions or causes of actions whatsoever arising out of any damage, loss or injury to me or my property, or death, while upon the premises or aircraft or while participating in any of the activities covered by this Agreement, whether resulting from the negligence and/or other fault, either active or passive, of any Releases, or from another cause.

**3. COVENANT NOT TO SUE.** I agree never to institute any suit or action of law or otherwise against any of the Releases, or to initiate or assist in the prosecution of any claim for damages or cause of action which I may have by reason of injury to my person or property, or my death, arising from the activities covered by this Agreement, whether caused by the negligence and/or other fault, either active or passive, of any of representatives, and/or anyone else claiming on my behalf, shall not institute any suit or action of law or otherwise against any Releases, nor shall they initiate or assist the prosecution of any claim for damages or cause of action which I, my heirs, executors, administrators, personal representatives, and/or anyone else claiming on my behalf may have by reason of injury to

my person or property or my death, arising from activities covered by this Agreement, whether caused by the negligence and / or other fault, either active or passive, of any Releases, or from any other cause. Should any such suit or action of law or otherwise be instituted against any of the Releases, I agree that such, Releases shall be entitled to recover attorney's fees and costs incurred in defense of such suit or action, including any appeals there from.
